### WEBSITE TERMS AND CONDITIONS OF USE

## **About the Website**

Welcome to www.macsfirewood.co.nz (the 'Website'). The Website provides you with an opportunity to browse and purchase various products that have been listed for sale through the Website (the 'Products'). The Website provides this service by way of granting you access to the content on the Website (the 'Purchase Services').

The Website is operated by Mac's Firewood (NZBN 9429050170531). Access to and use of the Website, or any of its associated Products or Services, is provided by Mac's Firewood. Please read these terms and conditions (the '**Terms**') carefully. By using, browsing and/or reading the Website, this signifies that you have read, understood and agree to be bound by the Terms. If you do not agree with the Terms, you must cease usage of the Website, or any of Services, immediately.

Mac's Firewood reserves the right to review and change any of the Terms by updating this page at its sole discretion. When Mac's Firewood updates the Terms, it will use reasonable endeavours to provide you with notice of updates to the Terms. Any changes to the Terms take immediate effect from the date of their publication. Before you continue, we recommend you keep a copy of the Terms for your records.

## **Acceptance of the Terms**

You accept the Terms by remaining on the Website. You may also accept the Terms by clicking to accept or agree to the Terms where this option is made available to you by Mac's Firewood in the user interface.

## **Registration to use the Purchase Services**

In order to access the Purchase Services, you must first register as a user of the Website. As part of the registration process, or as part of your continued use of the Purchase Services, you may be required to provide personal information about yourself (such as identification or contact details), including:

Telephone number

You warrant that any information you give to Mac's Firewood in the course of completing the registration process will always be accurate, correct and up

date.

Once you have completed the purchase process, you will be a registered user of the Website ('**User**') and agree to be bound by the Terms. As a User you will be granted immediate access to the Purchase Services.

You may not use the Purchase Services and may not accept the Terms if:

you are not of legal age to form a binding contract with Mac's Firewood; or you are a person barred from receiving the Purchase Services under the laws of New Zealand or other countries including the country in which you are resident or from which you use the Purchase Services.

# Your obligations as a User of the site

As a User, you agree to comply with the following: You will use the Purchase Services only for purposes that are permitted by:

the Terms:

any applicable law, regulation or generally accepted practices or guidelines in the relevant jurisdictions;

You are solely responsible for protecting the confidentiality of your password and/or email address. Use of your password by any other person may result in the immediate cancellation of the Purchase Services;

any use of your registration information by any other person, or third parties, is strictly prohibited. You agree to immediately notify Mac's Firewood of any unauthorised use of your password or email address or any breach of security of which you have become aware;

access and use of the Website is limited, non-transferable and allows for the sole use of the Website by you for the purposes of Mac's Firewood providing the Purchase Services;

you will not use the Purchase Services or Website for any illegal and/or unauthorised use which includes collecting email addresses of Users by electronic or other means for the purpose of sending unsolicited email or unauthorised framing of or linking to the Website;

you agree that commercial advertisements, affiliate links, and other forms of solicitation may be removed from the Website without notice and may result in the termination of the Purchase Services. ## **Purchase of Products and Returns Policy**

In using the Purchase Services to purchase the Product through the Website, you will agree to the payment of the purchase price listed on the Website for the Product (the 'Purchase Price'). Prices are subject to change without notice. Prices of bulk firewood are sold by the thrown cubic metre. Seasoned firewood is defined as firewood that has been left to dry in log form in our yard. The moisture content may vary from log to log and some additional drying time may be necessary.

Payment of the Purchase Price may be made online through Stripe (the 'Payment Gateway Provider'), or in person at the time of delivery via cash or bank transfer. In using the Purchase Services, you warrant that you have familiarised yourself with, and agree to be bound by, the applicable Terms and Conditions of Use, Privacy Policy and other relevant legal documentation provided by the Payment Gateway Providers.

WINZ quotes/payments will incur \$20.00 administration fee added to the quote

Following payment of the Purchase Price being confirmed by Mac's Firewood, you will be issued with a receipt to confirm that the payment has been received and Mac's Firewood may record your purchase details for future use.

Once delivery of the firewood has been taken Mac's Firewood does not accept any returns of the product, You acknowledge and agree that you are liable for any issues with the product after delivery.

Macs Firewood accepts cancellation the day prior to delivery and will issue a full refund. Any cancellations made via WINZ that are cancelled will incur a \$20.00 fee for administration. Any cancellations on the day of delivery will forfeit any monies paid to Macs Firewood.

Delivery times can take up to 1-2 weeks in the off-peak season and peak seasons can take up to 28 days, please contact our office to find out current delivery times and pricing. Deliveries may be weather dependent.

Seasoned firewood is defined as firewood that has been left to dry in log form in our yard. The moisture content may vary from log to log and some additional drying time may be necessary. Ideal for late winter. This wood is not covered under the 100% Guaranteed dry. It is the customers responsibility to choose the correct wood and dryness for their needs. Firewood is subject to availability.

Use of the Website, the Purchase Services, and any of the products of Mac's Firewood, is at your own risk. Everything on the Website, the Purchase Services, and the Products of Mac's Firewood, are provided to you on an "as is" and "as available" basis, without warranty or condition of any kind. None of the affiliates, directors, officers, employees, agents, contributors, third party content providers or licensors of Mac's Firewood make any express or implied representation or warranty about its Content or any products or Purchase Services (including the products or Purchase Services of Mac's Firewood) referred to on the Website. This includes (but is not restricted to) loss or damage you might suffer as a result of any of the following:

# **Dispute Resolution**

## Compulsory:

If a dispute arises out of or relates to the Terms, either party may not commence any Tribunal or Court proceedings in relation to the dispute, unless the following clauses have been complied with (except where urgent interlocutory relief is sought).

#### Notice:

A party to the Terms claiming a dispute ('**Dispute**') has arisen under the Terms, must give written notice to the other party detailing the nature of the dispute, the desired outcome and the action required to settle the Dispute.

## Resolution:

On receipt of that notice ('**Notice**') by that other party, the parties to the Terms ('**Parties**') must:

Within 28 days of the Notice endeavour in good faith to resolve the Dispute expeditiously by negotiation or such other means upon which they may mutually agree;

If for any reason whatsoever, 28 days after the date of the Notice, the Dispute has not been resolved, the Parties must either agree upon the selection of a mediator or request that an appropriate mediator be appointed by the President of the or his or her nominee;

The Parties are equally liable for the fees and reasonable expenses of a mediator and the cost of the venue of the mediation and without limiting the foregoing undertake to pay any amounts requested by the mediator as

a pre-condition to the mediation commencing. The Parties must each pay their own costs associated with the mediation;

The mediation will be held in Gisborne, New Zealand.

### Confidential:

All communications concerning negotiations made by the Parties arising out of and in connection with this dispute resolution clause are confidential and to the extent possible, must be treated as "without prejudice" negotiations for the purpose of applicable laws of evidence.

### Termination of Mediation:

If 30 days have elapsed after the start of a mediation of the Dispute and the Dispute has not been resolved, either Party may ask the mediator to terminate the mediation and the mediator must do so.

### Venue and Jurisdiction

The Purchase Services offered by Mac's Firewood is intended to be viewed by residents of New Zealand. In the event of any dispute arising out of or in relation to the Website, you agree that the exclusive venue for resolving any dispute shall be in the courts of Gisborne, New Zealand.

## Governing Law

The Terms are governed by the laws of New Zealand. Any dispute, controversy, proceeding or claim of whatever nature arising out of or in any way relating to the Terms and the rights created hereby shall be governed, interpreted and construed by, under and pursuant to the laws of New Zealand, without reference to conflict of law principles, notwithstanding mandatory rules. The validity of this governing law clause is not contested. The Terms shall be binding to the benefit of the parties hereto and their successors and assigns.

## **Independent Legal Advice**

Both parties confirm and declare that the provisions of the Terms are fair and reasonable and both parties having taken the opportunity to obtain independent legal advice and declare the Terms are not against public policy on the grounds of inequality or bargaining power or general grounds of restraint of trade.

### Severance

If any part of these Terms is found to be void or unenforceable by a Court of competent jurisdiction, that part shall be severed and the rest of the Terms shall remain in force.
